PREAMBLE

Virudhunagar Hindu Nadars' Senthikumara Nadar College (Autonomous), Virudhunagar has always been pleased to help the poor and needy students on campus. The motto of the college is "Low Cost Access to High Quality Education". According to VHNSN College motto, no student admitted on merit will discontinue his/her studies because of financial difficulties. Today, Education for all has become the order of the day and keeping in view, the VHNSN College Managing Board makes sure that education is affordable to all and it provides financial support for the students to become graduates and post graduates. The management also helps to create a conducive environment to the students so that they can concentrate on their studies without worrying about financial matters.

VHNSN College has evolved a scholarship policy for the students detailing the following rules and regulations.

DEFINITIONS

Institutional Scholarships: Institutional Scholarship/Freeships refers to scholarships that are established by the institution from internal funds

Government Scholarships: Government Scholarship refers to scholarships that are offered by the Central/Tamil Nadu State Governments.

NGO Scholarships: A non-profit organization that operates independently of any government, typically one whose purpose is to address a social issue.

OBJECTIVES

- To inform the students about the various government and non-government scholarship opportunities.
- To support deserving candidates in their pursuit of government and non-government scholarships and freeship.
- To ensure the freeship for the economically disadvantaged students.

III. INSTITUTIONAL SCHOLARSHIPS/FREESHIPS

Virudhunagar Hindu Nadars' Senthikumara Nadar College (Autonomous), Virudhunagar believes in encouraging the meritorious students and making education affordable to the underprivileged students. Deserving students with excellent academic records are given educational scholarships and fee concessions.

Management Scholarship

VHNSN College Managing Board offers scholarship/freeship to students under various schemes like Helping Others Pursue Education (Hope), Project Assistance for Students (PASS), Freeship for Value Added Courses, Sports scholarship, Earn While You Learn and VHNSNC Alumni Association Scholarship.

Helping Others Pursue Education (HOPE)

The prime objective of this scheme is to provide financial assistance to the meritorious students in curricular and extra-curricular activities to meet a part of their educational expenses. This scholarship is for the students who are unable to afford the cost of education or belong to certain socio-economically backward sections of society, wherein the annual income of the family is a determining factor are eligible to get this scholarship.

Project Assistance for Students (PASS)

Virudhunagar Hindu Nadars' Senthikumara Nadar College (Autonomous), Virudhunagar has been implementing **Project Assistance for Students** Scheme in order to harness the talent and potential available with the students. Under this Scheme financial support is provided to encourage the final year students of U.G /P.G and to take up useful minor research projects to complete the dissertation work.

Freeship - Value Added Courses

As an initiative towards enhancing the students' existing skills sets, the college has introduced a number of value added courses. Value-Added Courses (VACs) are additional educational offerings that provide students with skills and knowledge that are beyond the standard curriculum. The courses typically consist of 30 or more hours of instruction and are taught by a combination of faculty members and industry or academic experts. With a view to supporting students, the freeships are offered in the form of 100% fee waiver to all enrolled students in every program.

Sports Scholarship

Sports scholarship is given to UG & PG students who have participated in the University, State, National and International level sports and games. The students excelled in sports and games during their school life are identified and they are supported through

various scholarships/ full or partial concession in the Tuition fee, based their achievements. The scholarship is extended to the subsequent years of study, provided the students have a minimum of 60% attendance, have no arrears and are duly certified by the Director of Physical Education.

VHNSNC Alumni Association Scholarship

Alumni association extends a helping hand in supporting the deserving students with an Alumni scholarship. With the support of VHNSNC Alumni Association Scholarship, the college mobilises fund from various sources, particularly through various alumni chapters, and distribute to deserving students for the purchase of study materials, such as textbooks and uniforms, and medical expenses *etc*. Scholarships are awarded to students based on their financial circumstances and academic performance. The students are selected based on their mark income and feedback from the department.

Earn While You Learn

The 'Earn While You Learn' concept is introduced to provide financial help to the needy students in exchange for academics related works. This initiative will have a 3-pronged result: 1. Students will earn extra pocket-money, 2. They gain some work experience, 3. Hands-on-training while studying; which is something our educational system lacks.

Post Graduate students and Research Scholars can take-up teaching assignments in our College itself, for Under Graduate students, or with tasks such as Data Entry, maintaining of student records, care-taker in the hostels (preferably at nights), library management *etc*.

Students belonging to certain socio-economically backward sections of society, wherein the annual income of the family is a determining factor are eligible to get this scholarship.

Research Scholarship

Ph.D Scholarships help several students to pursue a research degree after successfully completing their postgraduate program. Ph.D provides the facilities to the students to research and contribute to a field of study. The Students must be full time Ph.D. research scholar either First year, Second year or Third year. (The scholar with M.Phil. qualification must be a student of I or II year of Ph. D. Course). They should not be in receipt of any other Scholarship. Part time Ph.D. Research Scholars are not eligible. Selection is made on merit basis.

PROCEDURE FOR AVAILING SCHOLARSHIP/FREE SHIPS

The college has been strictly following specific regulations to identify students for scholarships and freeships. Class teachers (Mentors) are in charge of identifying the deserving students in each class based on their academic performance and financial circumstances. Students must submit to the Head of the Department a duly filled application with the recommendation of the concerned Class teacher and parents' signature. The applications are forwarded to the VHNSNC-Institutional Scholarship Committee after getting it verified by the Head of Department. The screening committee review the application and assign a quantum of the fund to each student based on their priorities. The college maintains proper records and audited statements of the receipt and disbursement of funds for institutional scholarships and freeships.

Fill all the details, submit it and submitted application has to be taken print and get the signature of Guide, HoD and SF Co-ordinator/Principal as the case may be. SCHEME OF 'POST-MATRIC SCHOLARSHIP' FOR STUDENTS BELONGING TO THE MINORITY COMMUNITIES

1. BACKGROUND

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that a post-matric scholarship scheme for meritorious students from minority communities would be implemented.

2. OBJECTIVE

The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

3. SCOPE

The scholarship is to be awarded for studies in India in a government or private higher secondary school/college/university, including such residential institutes of the Government and eligible private institutes selected and notified in a transparent manner by the State Government/Union Territory Administration concerned. It will also cover technical and vocational courses in Industrial Training Institutes/ Industrial Training Centres affiliated with the National Council for Vocational Training (NCVT) of classes XI and XII level including Polytechnics and other courses (any course of less than one year duration is not covered under this scheme; Certificate courses are also not covered).

4. ELIGIBILITY

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardians from all sources does not exceed Rs.2.00 lakh.

11. DISTRIBUTION

Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. A total of five (05) lakh scholarships are targeted to be distributed as 'Fresh' Scholarships, besides, Renewal scholarships. The distribution of scholarship among the States/Union Territories will be made on the basis of population of minorities in the States/Union Territories as per Census 2001 for 2017-18 and as per the population of minorities in the States/Union Territories of Census 2011 for 2018-19 and 2019-20 (as per Appendices- A & B).

6. EARMARKING

- 30% scholarship is earmarked for girls students of each minority community in a State/UT which is transferable to male students of that community in case of non-availability of female students in that community in the concerned State/UT.
 30% is the floor and not the ceiling for eligible girl students.
- ii) If the physical target of scholarship for a particular minority community in a state/UT is not utilized, it will be distributed among the same minority

community in other States/UTs strictly in accordance with merit and without disturbing the national ratio. Any unutilized community quota shall be distributed amongst other communities again in accordance with merit and without affecting the overall national quota.

iii) A student residing in a particular State/UT will be entitled for scholarship under the quota of that State/UT only irrespective of his/her place of study.

7. SELECTION PROCEDURE

Fresh - As the number of scholarships for minorities available in a year is fixed and limited, it is necessary to lay down preference for selection. Inter-se selection weightage is to be given to poverty rather than marks (the applicant is required to submit an income certificate as per para-11(ii)). In case of same income, merit shall be generated from 'Date of Birth' criteria of applicant (senior is preferred).

Renewal – There is no merit list generation for renewal cases. Renewal applicant will get the scholarship if one has obtained 50% in his/her previous year's examinations (at the same institute and in same course) and his/her application is verified by all authorities (as designated by Ministry of Minority Affairs) and approved by State Governments/UTs.

8. DURATION

The scholarships shall be provided for the entire course of the academic year. Maintenance allowance will be given as fixed lump sum amount in an academic year (as per para-9 below) for 2017-18 to 2019-20.

9. RATES OF SCHOLARSHIP

10. IMPLEMENTING AGENCIES

The scheme is being implemented/funded by Ministry of Minority Affairs through the States/UT's Administration.

11. CONDITIONS FOR SCHOLARSHIP

- (i) Scholarship will be awarded to the students studying in Classes XI and XII including technical and vocational courses of this level including Polytechnics, ITIs, and other courses.
- (ii) An Income Certificate, issued from a Competent Authority in the State/UT Governments is required in respect of parent/guardian of the student.
- (iii) A Self-Certified Community Certificate is required from the student who has attained 18 years of age. For others the Community Certificate certified by parent/guardian of the student is required.
- (iv) The continuance of award (for Renewal applicants) will be subject to securing 50% marks in the previous year's examination (provided the students pursues the same course and same Institute/School).
- (v) Maintenance allowance will be provided to hostellers and day scholars.
- (vi) Scholarship will not be given to more than two students from a family (applicable for all Scholarship schemes meant for minorities under this Ministry taken together).
- (vii) Students should be regular in attendance for which the yardstick will be decided by the competent authority of the school.
- (viii) The school/institute will certify the claim of student of being an outstation student not residing in hostel of the school/institute concerned on the basis of permanent address and parents' address.
- (ix) Migration of students from one school/institute to another is not allowed for renewal applicants during the period of academic course.
- (x) If a student violates school discipline or any other terms and conditions of the scholarship, scholarship may be suspended or cancelled. The State Government/Union Territory Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.

- (xiv) A student shall be eligible for only one scholarship out of all the available Scholarships of Central Government meant for SC/ST/OBC/ minority.
- (xv) The amount of Administrative Expenses (@ 2%) for States/UTs in subsequent

- year shall be released after receiving the utilization certificate for the previous years.
- (xvi) The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of the evaluation will be borne by the Ministry of Minority Affairs under the provision of the scheme.
- (xvii) The State/Union Territory shall place all relevant details of financial and physical achievements on their website.
- (xviii) The regulations can be changed at any time at the discretion of the Government of India.
- (xix) It will be necessary for the eligible applicants to provide Aadhaar number while applying for the scholarship and in case, an individual does not possess Aadhaar one can provide the details of alternative identification documents, as stated in the Gazette Notification- S.O. No. 1284 (E) No. 1137, dated 21.04.2017 (as per Appendix-C).
- (xx) Students who have entered Aadhaar in their online application correctly and Aadhaar seeded with any of their bank account, in such cases the amount of scholarship will be credited to Aadhaar seeded bank account only (though student has mentioned any other non-seeded bank account in online application).

12. ADMINISTRATIVE EXPENSES

As the magnitude of data to be entered and processed would be enormous as the scheme gets implemented over the years, there would be a need to engage qualified skilled personnel right from the beginning to ensure that the data based computerized systems are operational. Qualified skilled personnel possessing requisite expertise to operate computer programme designed for this purpose, enter, process, analyse, monitor, retrieve and transfer data should be engaged on contract basis as per need. Data provided by the States/Union Territories will be maintained and managed by the Ministry with personnel of similar expertise to be engaged on contract basis.

16. PATTERN OF FINANCIAL ASSISTANCE

The scheme is Central Sector Scheme and 100% funding is provided by the Ministry of Minority Affairs.

17. MONITORING & TRANSPARENCY

The State/Union Territory shall maintain year-wise details of the students receiving scholarship, indicating school/institute, location of school/institute, government or private, class, gender, new or renewal, permanent address and parents' address. The States/ Union Territories shall place relevant physical and financial details in their official website

SCHEME OF 'MERIT CUM MEANS BASED SCHOLARSHIP' FOR STUDENTS BELONGING TO THE MINORITY COMMUNITIES

1. OBJECTIVE

The objective of the Scheme is to provide financial assistance to the poor and meritorious students belonging to minority communities to enable them to pursue professional and technical courses.

2. SCOPE

The scholarship is to be awarded for studies in India in a Government or private institution, selected and notified in a transparent manner by the State Government/Union Territory Administration concerned. It will cover technical and professional courses at undergraduate and post graduate level. A list of courses are at Appendix-E.

3. ELIGIBILITY

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardians from all sources does not exceed Rs.2.50 lakh.

4. DISTRIBUTION

Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. A total of 60,000 scholarships are targeted to be distributed as 'Fresh' Scholarships, besides, Renewal scholarships. The distribution of scholarship among the States/Union Territories will be made on the basis of population of minorities in the States/Union Territories as per Census 2001 for 2017-18 and as per the population of minorities in the States/Union Territories of Census 2011 for 2018-19 and 2019-20 (as per Appendices- A & B).

5. EARMARKING

- 30% scholarship is earmarked for girls students of each minority community in a State/UT which is transferable to male students of that community in case of non-availability of female students in that community in the concerned State/UT.
 30% is the floor and not the ceiling for eligible girl students.
- ii) If the physical target of scholarship for a particular minority community in a state/UT is not utilized, it will be distributed among the same minority community in other States/UTs strictly in accordance with merit and without disturbing the national ratio. Any unutilized community quota shall be distributed amongst other communities again in accordance with merit and without affecting the overall national quota.
- iii) A student residing in a particular State/UT will be entitled for scholarship under the quota of that State/UT only irrespective of his/her place of study.

6. SELECTION PROCEDURE

- (i) Fresh The number of scholarship has been fixed State/UT-wise on the basis of Community-wise minority population of the States/UTs as per Census 2001 (2017-18) & 2011 (2018-20). Within the State-wise allocations, the applications from Listed Institutions will be exhausted first in merit list. In case number of such students is more than the State/Community-wise quota, normal merit list criteria shall be followed. Other verified applicant/student will be selected in the merit list, thereafter, on merit basis i.e. Percentage/marks of last academic course/board (higher secondary / graduation) exam. In case of similar marks, income will be taken as deciding factor.
- (ii) Renewal There is no merit list generation for renewal cases. Renewal applicant will get the scholarship if one has obtained 50% in his/her previous year's examinations (or in each semester/trimester of previous year's) their application is approved by State Governments/UTs.

7. DURATION

Scholarship will be provided for the entire academic year/course. Similarly, the maintenance allowance will be given as fixed lump sum amount for an academic year (Rs. 10,000/- for Hosteller and Rs. 5,000/- for Day Scholar).

8. RATE OF SCHOLARSHIP

The details of the scheme interventions for the three years viz.2017-18 to 2019-20 are as under:

9. LIST OF INSTITUTES FOR FULL COURSE FEE REIMBURSEMENT

There is a list of 85 Reputed Premier Institutes, covered under the scheme, for which a student is eligible for full Course Fee reimbursement as scholarship during an academic year. A list of such Institutes is at Appendix – C.

10. CONDITIONS FOR SCHOLARSHIP

- (i) Students who get admission to a college to pursue technical/professional courses, on the basis of a competitive examination will be eligible for the scholarship.
- (ii) Financial assistance will be given to pursue graduate level or post graduate level technical and professional courses from a recognized institution Admission and Course fee and Maintenance allowance for the year of scholarship will be

- credited/transferred directly into the bank account of selected students.
- (iii) Students who get admission in technical/professional courses without taking any competitive examination will also be eligible for scholarship. However, such students should have secured not less than 50% marks in last qualifying exam at higher secondary/graduation level in case of Fresh Scholarship only. Selection of these students will be done strictly on merit basis
- (iv) An Income Certificate, issued from a Competent Authority in the State/UT Governments is required in respect of parent/guardian of the student.
- (v) A Self-Certified Community Certificate is required from the student who has attained 18 years of age. For others the Community Certificate certified by parent/guardian of the student is required.
- (vi) The continuance of award (for Renewal applicants) will be subject to securing 50% marks in the previous year's examination (each semester / trimester of previous year provided the students pursues the same course in same Institute).
- (vii) Maintenance allowance will be provided to hostellers and day scholars.
- (viii) The award will be discontinued if a student fails to secure 50% marks in the previous annual examination (as stated in para-vi above).
- (ix) Scholarship will not be given to more than two students from a family (applicable for all three Scholarship schemes meant for minorities under this Ministry taken together).
- (x) Students should be regular in attendance for which the yardstick will be decided by the competent authority of the institutions.
- (xi) The institute will certify the claim of student of being an outstation student not residing in hostel of the institute concerned on the basis of permanent address and parents' address.
- (xii) Migration of students from one school/institute to another is not allowed for renewal applicants during the period of academic course.
- (xiii) If a student violates institution's discipline or any other terms and conditions of the scholarship, scholarship may be suspended or cancelled. The State Government/Union Territory Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.
- (xiv) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered by the concerned State/UT Govt. The student shall also be black listed and debarred for scholarship in any scheme forever.
- (xv) The Course fees and Maintenance allowance (for 2017-20) will be credited to the student's bank account directly under Direct Benefit Transfer (DBT) mode.
- (xvi) The student obtaining benefits under this scheme shall not be allowed to avail of benefits under any other scheme for this purpose.
- (xvii) A student shall be eligible for only one scholarship out of all the available Scholarships of Central Government meant for SC/ST/OBC/minority.
- (xviii) The amount of Administrative Expenses (@ 2%) for States/UTs in subsequent year shall be released after receiving the Utilization Certificate for the previous years.
- (xix) The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of the evaluation will be borne by the Ministry of Minority Affairs under the provision of the scheme.
- (xx) The State/Union Territory shall place all relevant details of financial and physical achievements on their website.

- (xxi) The regulations can be changed at any time at the discretion of the Government of India.
- (xxii) Scholarship will not be paid for the period of internship/housemanship in the M.B.B.S. course or for a practical training in other course if the student is in receipt of some remuneration during the internship period or some allowance/stipend during the practical training in other course.
- (xxiii) It will be necessary for the eligible applicants to provide Aadhaar number while applying for the scholarship and in case, an individual does not possess Aadhaar one can provide the details of alternative identification documents, as stated in the Gazette Notification No. 1137, dated 21.04.2017 (as per Appendix-D)
- (xxiv) Students who have entered Aadhaar in their online application correctly and Aadhaar seeded with any of their bank account, in such cases the amount of scholarship will be credited to Aadhaar seeded bank account only (though student has mentioned any other non-seeded bank account in online application).
- (xxv) The scholarship is dependent on the satisfactory progress and conduct of the scholar. If it is reported by the Head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc., the authority sanctioning the scholarship may either cancel the scholarship or stop or withhold further payment for such period as it may think fit.
- (xxvi) A scholar is liable to refund the scholarship amount, if during the course of the year, the studies for which the scholarship has been awarded, is discontinued or change in the subject of study.

18. EVALUATION

The monitoring of the financial and physical performance of the scheme will be evaluated by assigning evaluation/impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India.

19. REVIEW, MODIFICATION (if any, during 2017-18 to 2019-20)

The progress of implementation of the scheme shall be reviewed by the Joint Secretary I/c of Scholarship Schemes in Ministry of Minority Affairs on monthly basis. Quarterly Review shall be done by Secretary, Minority Affairs, Government of India.



GUIDELINES FOR POST GRADUATE INDIRA GANDHI SCHOLARSHIP FOR SINGLE GIRL CHILD

1. INTRODUCTION

It is observed that number of girls as against boys in certain states is declining which is a matter of great concern. The females are even forced to give birth to male child. In such circumstances education of women needs to be used and effective means for their empowerment and education will prepare them to have a control over their lives. The mindset which militates against the girl child could not keep pace with economic progress and literacy. The Government of India declared elementary education as a basic human right of every child. The Union Government of India has taken various steps to uplift the status of women by implementing various schemes including free education for girls. In order to achieve and promote girls education, UGC has introduced a Post Graduate Indira Gandhi Scholarship for Single Girl Child with an aim to compensate direct costs of girl education to all levels especially for such girls who happen to be the only girl child in their family.

2. OBJECTIVES

The objectives of the proposed scheme are:

- a) To support post graduate education of single girl child in postgraduate courses only.
- b) To recognize the value of observance of small family norm.

3. TARGETGROUP

- Girl students who are admitted in the first year of PG courses in the following Universities / Colleges and happen to be the only girl child in the family:
- Universities/Institutions/Colleges included under section 2(f) & and 12(B) of UGC Act.
- Deemed to be Universities included under Section 3 of the UGC Act, 1956 and eligible to receive grants-in-aid from UGC. Those Deemed Universities which do not receive funds from the Central/ State Government are not eligible institutions under the scheme.
- Universities/Institutions/College funded by Central/State Government.
- Institutes of National Importance.
- Girl students without having any brother or the girl student who are twin daughters/ fraternal daughter may also apply for scholarship under the aforesaid scheme. In a family if one son and one daughter is available then girl child will not be considered for scholarship under the scheme.

4 ELIGIBILITY

- **Slots**: 3000
- **Age limit**: Girl students up to the age of 30 years at the time of admission in first year of PG courses are eligible.
- The scheme is applicable to such single girl child who has taken admission in regular, full-time first year Masters Degree course in any designated university or a post graduate college.
- Admission to PG Course in Distance education mode is not covered under the scheme.

5 NATURE OF ASSISTANCE AVAILABLE UNDER THESCHEME

Amount of fellowship: Rs.36,200/- p.a. for a period of two years only i.e. full duration of a PG course. No other additional grant will be payable in lieu of hostel charges and medical charges etc.

6 PROCEDURE FORAPPLYING

- The candidates fulfilling the eligibility conditions are required to apply online on National Scholarship Portal after initiation of application process and notice to be published on UGC website.
- The host institution where the candidate is studying is required to verify the online application.
- It is expected from the institutions where student has taken admission in the first year PG course, no tuition fees will be charged by the institute from girl students to pursue PG degree course in Universities/Colleges/Institutions

7 AADHAARSEEDING

The Ministry of Human Resource Development, Government of India vide its letter D.O. No. 18-7/2013-U1A dated 10th June, 2016 has instructed the University Grants Commission that from the financial year 2016-17 onwards the Aadhaar will be used as an identifier for disbursement of all Government subsidies/Scholarships/Fellowships which are to be disbursed directly into the beneficiary's account. The disbursals will be governed by the Aadhaar Act, 2016.

8. PROCEDURE FOR APPLYING FOR THE SCHEME

- Applications will be invited once in a year on the National e-Scholarship Portal of the Government of India. Short notification will also be uploaded on the UGC website.
- Incomplete applications will be summarily rejected. Only verified online applications will be considered for award of scholarship.
- ➤ Affidavit regarding Single girl child status may be uploaded as per format given in Annexure-II.
- ➤ Joining report as per Annexure-I has to be uploaded.

9. SELECTION PROCEDURE

- > 3,000 fresh scholarships will be awarded every year.
- The awardee can avail of other scholarship also during the tenure of this scholarship.

GUIDELINES FOR POST GRADUATE MERIT SCHOLARSHIP SCHEME FOR UNIVERSITY RANK HOLDERS AT UNDER GRADUATE LEVEL

1. INTRODUCTION

Higher Education has had played a very vital role in the history of nation building all over the world. It is amply clear that no rise in general standards of living and culture is possible without strengthening the higher education system in the country. It obviously calls for a multipronged strategy. There is a need to modernize our higher education system, and equally important to continuously attract young and talented students to pursue higher education. It is being increasingly observed that the brighter lot is not pursuing Post-Graduate education in our institutions of higher learning.

To emerge as a powerful nation, there is an urgent need to bring in talented boys and girls in the field of Post-Graduate education by way of providing them good incentives in the form of scholarships. The UGC, therefore, introduced a Post-Graduate Merit Scholarship Scheme for University undergraduate rank holders.

The scholarship may be tenable for a period of two years to enable the rank holders of each university at undergraduate level to pursue their Master's Degree. All universities/degree awarding institutions would be required to issue rank certificates to the toppers of the university in B.A., B.Sc., and B.Com.

The purpose of this scheme is to attract talent for pursuing post graduate studies besides strengthening the basic subjects at Undergraduate level. The awardees, under this scheme, can pursue their Postgraduate programme in any area of specialization in any institution of higher learning in the country.

2. OBJECTIVES OF THE SCHEME

The objectives of the scheme are:

- **2.1.** To promote and nurture talent:
- **2.2.** To reward meritorious students with outstanding performance at the Under graduate level for pursuing postgraduate studies;
- **2.3.** To promote study in basic courses at undergraduate level. Professional courses are not covered under the scheme:
- **2.4.** To build up academic excellence at postgraduate level across the colleges and universities in the country.

3. TARGET GROUP

- 3.1 The First and Second Rank holders at undergraduate level and admitted in any Postgraduate Course would be awarded the scholarship. The students will have to submit the proof of their merit position at undergraduate level as well as their admission in postgraduate courses as per Annexure-I.
- 3.2 The scholarship would, however, be subjected to securing a minimum of sixty percent marks at undergraduate level. The joining report has to be uploaded as per format at Anenxure-II.
- 3.3 The scheme is applicable to such students who have taken admission in regular, full-time Master's Degree course in any recognized university, deemed university, private university, autonomous college or a post graduate college.

4. ELIGIBILITY

- **4.1** The scholarship is available to the student for first PG Degree only. Age limit for the students is 30 years at the time of admission in PG course.
- **4.2** Distance mode of education will not be considered under the scheme.
- **4.3** The Undergraduate courses from following streams have been identified for the award of scholarships:

1.Life Sciences 2. Physical Sciences 3. Chemical Sciences 4. Earth Sciences 5. Mathematical Sciences 6. Social Sciences 7. Commerce 8. Languages

- **4.4** Before verifying applications of students the concerned Universities may ensure that applicants satisfy all norms as per guidelines.
- **4.5** The first and second rank holders (**Not position holders**) would be considered from Universities/ Institutions and non-affiliated/ autonomous colleges according to the number of students who have appeared in the examination at undergraduate level as per following table.

- The concerned University/ Institute should verify that the applicant is a first or second rank holder out of the specified total number of students who appeared in the examination at the undergraduate level as specified in the guidelines.

7. JOINING

The scholar would be awarded from the date of joining the post graduate first year course as per information provided in the online application and verified by the University/ Institute/ College.

8. DISBURSAL OF SCHOLARSHIP

- After selection, the awardees will be paid scholarship on DBT mode.
- ➤ The list of awardees will be pushed to Public Financial Management System (PFMS) by the NIC.
- ➤ PFMS will generate payment files of the awardees and scholarship would be paid for the complete duration of the post graduate course. Payments will be generated on annual basis.

- > Scholarship granted under the scheme will be kept renewed during the period of postgraduate course subject to good conduct and maintenance of prescribed attendance.
- > The scholarship will be renewed for the next year of study on receipt of renewal form.
- > Students failing to get promoted to the next class/ level would forfeit the scholarship.
- > Change in course of study will not be permitted.
- > Scheme will be implemented and monitored by the UGC.
- ➤ The awardees of previous years will continue to follow the UGC pattern of assistance through the designated bank branches of Canara Bank.

- **17.2** Unsatisfactory progress report (i.e. if the candidate scores less than 60% marks in the first year of Master's programme).

GUIDELINES FOR POST GRADUATE SCHOLARSHIPS FOR PROFESSIONAL COURSES FOR SC/ST CANDIDATES

1. Introduction

The scheme has been initiated keeping in view the social background of the candidates from the deprived section of the society and to provide them opportunity to undertake postgraduate level studies in Professional subjects like Engineering & Technology, Management, Pharmacy etc. in Indian Universities/Institutions/ Colleges.

2. Objective

The objective of the scheme is to provide financial assistance to 1000 SC/ST candidates to pursue postgraduate level studies in Professional subjects in the eligible institutions as given below.

3. Eligibility

For the purpose of award of the scholarship students who are pursuing professional courses in the following Institutions/ Colleges/Universities:

- Universities/Institutions/Colleges included under section 2(f) & and 12(B) of UGCAct.
- Deemed to be Universities included under Section 3 of the UGC Act, 1956 and eligible to receive grants-in-aid from UGC,
- Universities/Institutions/College funded by Central/StateGovernment.
- Institutes of National Importance.

Courses which require approval from Regulatory Council i.e. Medical Council of India (MCI), Dental Council of India (DCI), Pharmacy Council of India (PCI), Rehabilitation Council of India (RCI), NCTIS, NCTE Bar council of India (BCI), All India Council for Technical Education (AICTE), Indian Council of Agricultural Research (ICAR), INC, FORENSIC REGULATORY & DEVELOPMENT AUTHORITY OF INDIA are considered professional courses.

Note 1: M.A., M.Sc., M.Com., MSW and Mass Communication and Journalism degree are accepted as "Non-professional courses":

Note 2: Candidates pursuing post graduate course in professional subjectsthroughcorrespondence or in Distance Education mode are **not eligible** to receive financial assistance under this scheme.

4. Procedure for applying for thescheme

- The candidates fulfilling the eligibility conditions are required to apply online on National Scholarship Portal after issue of advertisement to be published by the UGC once in a year through leading newspaper and Employment News and also on UGC website.
- The host institution where the candidate is studying is required to verify the online application.

5. Aadhaar Seeding

The Ministry of Human Resource Development, Government of India vide its letter D.O. No. 18-7/2013-U1A dated 10th June, 2016 has instructed the University Grants Commission that from the financial year 2016-17 onwards the Aadhaar will be used as an identifier for disbursement of all Government subsidies/ Scholarships/Fellowships which are to be disbursed directly into the beneficiary's account.

The Aadhaar details would be updated by the student through the host University/ Institute/ College after seeking a consent from the awardee as per provisions of the Aadhaar Act, 2016.

6. Nature of Assistance available under the Scheme

- 6.1 The tenure of award is for two/three years depending upon tenure of the postgraduate course and **not for extended period of study, ifany.**
- 6.2 Candidates selected for the award of PG scholarships (under ME/MTech.) shall be provided Scholarship @ **Rs.7800**/-per month for the duration of the PG Scholarship. For other courses, the amount of scholarship will be paid @Rs.4500/- per month.
- 6.3 No contingency is payable to the students selected under the scheme with effect from selection year 2017-18.
- 6.4 The scholarship shall be payable to the awardee from the date of joining the Post Graduate I year course during the selection year.
- 6.5 The University/ Institute/ College should verify the application of the candidates with regard to the professional courses as provided in the guidelines.

7. Procedure for release of grant by the UGC

- 7.1 After selection, the awardees will be paid scholarship on DBT mode.
- 7.2 The list of awardees will be pushed to Public Financial Management System (PFMS) by the NIC.
- 7.3 PFMS will generate payment files of the awardees and scholarship would be paid for the complete duration of the post graduate course.

8. Renewals

- 8.1 Scholarship granted under the scheme will be kept renewed during the period of first year post graduate course subject to good conduct and maintenance of prescribed attendance.
- 8.2 The scholarship will be renewed for the next year of study on receipt of an annual progress report to be granted by the administrative head of the University/ Institution/ College.(E.g. Registrar of a University/ Director of the Institution/ Principal of the College or any other officer designated by them).
- 8.3 Students failing to get promoted to the next class/ level would forfeit the scholarship.
- 8.4 Change in course of study will not be permitted.
- 8.5 Scheme will be implemented and monitored by the UGC.
- 8.6 The awardees of previous years will continue to follow the UGC pattern of assistance through the designated bank branches of Canara Bank.

9. Cancellation of Award

Scholarship of a student may be cancelled in any of the following cases:-

- Failure of the awardee to pass the first year of Post Graduate course in first division or equivalent CGPAscore.
- Discontinuation of studies due to personal reasons.
- Candidate is later found ineligible on account of false information provided in the online application or incorrect bank details.

FAQs

- 1. Are all candidates pursuing post graduate courses in Indian Universities/ Colleges/ Institutes eligible for this award?
 - No. This scheme is meant only for SC/ST students. General category/ OBC candidates are not eligible to apply under the scheme.
- 2. Are students belonging to SC/ST category who are pursuing post graduation through correspondence/ distance mode eligible for the award?
- 3. No. Candidates pursuing post graduate course in professional subjects through correspondence or in Distance Education mode are **not eligible** to receive financial assistance under this scheme.
- 4. Are awardees selected under this scheme eligible to draw contingency and HRA? No. The awardees are only eligible to receive scholarship amount.
- 5. Are students of eligible category who are pursuing post graduation and are in the second year of study eligible to apply under the scheme?

 No. Only students pursuing first year of postgraduate course during the current academic year are eligible to apply.



GUIDELINES FOR SWAMI VIVEKANANDA SINGLE GIRL CHILD FELLOWSHIP FOR RESEARCH IN SOCIAL SCIENCES

1. INTRODUCTION

Swami Vivekananda was one of the great social thinker and pioneer in social reforms in India. He was chief disciple of Saint Ramakrishna Paramhansa. In a short life span of just 39 years, he introduced Vedanta and Yoga to the western world. Swamiji stressed on different aspects of religion, education character building and social issues pertaining to India. Swami Vivekananda believed that "Education is manifestation of perfection already in men". To him education was not mere collection of information, but is more meaningful. He stressed that education should be man-making, life giving and Character building. Education is assimilation of noble ideas. He stressed to combine dynamic and scientific attitude of west with spirituality of our country. In women education he emphasizes on fearlessness. Swami Vivekananda considered women to be incarnation of power and asked men to respect them in every way. He believed that the nation can move forward only when the women of the country secure a respectable place. He considered men and women to be equal. He was of the view that women just like men should be allowed to enjoy freedom, independence and responsibility. Swamiji stressed upon the importance of women education and believed that the main reason behind various problems of women in our country was lack of proper education. He firmly believed that if women get proper education then they will solve their problems in their own ways. The main objective in his scheme of women education was to make them strong, fearless, and conscious of their dignity.

In our country like many other developing countries of the world, girl child is discriminated against from her birth, throughout her childhood and into her adulthood. It is very much evident from the skewed sex ratio in favor of men to women (men outnumber women) as sons are preferred over daughters. In many states the sex ratio is alarmingly low. The evil of female feticide is prevalent in most part of the country. The situation is not good for the society as this may further increase crime against women. The root cause of this discrimination is lack of education, indifferent attitude and

practices of the society against girl child and status of women in our society. In such circumstances education of women needs to be used and effective means for their empowerment and education will prepare them to have a control over their lives. The Govt. of India declared elementary education as a basic human right of every child. The Union Government of India has taken various steps to uplift the status of women by implementing various schemes including free education for girls.

Promotion of women education is one of the main objectives of our education policy. It is observed that the dropout ratio at various levels of education for girls is much higher than that of boys. Therefore new initiatives have become necessary to give girl child equality and dignity. In order to achieve state governments, central governments and UGC have started special schemes/Fellowships for girls. The government of India is giving special benefits for families having single girl child. Promotion of single girl child in the family means promoting girls in the society, increase sex ration in favor of women and promotion of small family norm in the society.

Keeping Swami Vivekananda's ideas of women education and to achieve and promote girls education, UGC has introduced Swami Vivekananda Fellowship for Single Girl Child for research in Social Sciences with an aim to compensate direct costs of higher education especially for such girls who happen to be the only girl child in their family.

2. OBJECTIVES

The objectives of the proposed scheme are:

- i. To support higher education of single girl child in Social Sciences.
- ii. To recognize the value of observance of small family norm.
- iii. To recognize the norm of single girl child in society.
- iv. To propagate the concept of single girl child norm.
- v. Promoting single girls in the society.

3. TARGET GROUP

The girl students who are admitted in Ph. D. program in Social Sciences in Universities/Colleges/ Institutes and happen to be the only girl child in the family without having any brother or sister. The girl student who are twin daughters/fraternal daughter may also apply for fellowship under the aforesaid scheme.

4. ELIGIBILITY

- i. Any single girl child of her parents pursuing Ph.D. in Social Sciences in Universities/Colleges/ Institutes is eligible to apply under the scheme. In a family if one son and one daughter is available then girl child will not be considered for fellowship under the scheme. Proof of being single girl child has to be submitted on an affidavit ofRs.50/- Stamp paper from the fellow/parent duly attested by SDM/First Class Magistrate/Gazetted Officer (not below the rank of Tahsildar) as per the prescribed proforma (Annexure I) at the time of filling the online application.
- ii. The scheme is applicable to such a single girl child who has registered herself in regular, full-time Ph. D. program in Social Sciences in Indian Universities/Colleges/Institutes as indicated below:
 - ➤ Universities/Colleges/Institutes included under section 2(f) and 12(b) of UGC Act, 1956.
 - ➤ Deemed to be Universities under section 3 of the UGC Act 1956 which are eligible to receive grant in aid from UGC.
 - ➤ Universities/Colleges/Institutes funded by Central/ State Govt.
 - > Institutes of National Importance.
- iii. Admission to Ph.D. Course in Distance education mode is not covered under the scheme.
- iv. Girl students up to the age of 40 years for general category and 45 years for the reserved categories i.e. SC/ST/OBC and PWD (Persons with Disabilities) as on the last date of submission of online application are eligible.
- v. Transgender candidates are eligible to apply under the scheme as per the norms.

5. AADHAAR SEEDING

The Ministry of Human Resource Development, Government of India vide its letter D.O. No. 18-7/2013-U1A dated 10th June, 2016 has instructed the University Grants Commission that from the financial year 2016-17 onwards the Aadhaar has been made mandatory for disbursement of all Government subsidies/Scholarships/Fellowships which are to be disbursed directly into the beneficiary's account. Accordingly, Aadhaar will be used as an Identifier for release of grant under the scheme.

6. NATURE OF ASSISTANCE AVAILABLE UNDER THE SCHEME

6.1 Slots

The number of slots for fellowship may be decided every year on the basis of eligible applications complete in all respects, received through online mode.

6.2 Tenure

The tenure of the fellowship is for five years and will be effective from 1st April of the selection year or the actual date of joining under the fellowship in the University/College/Institute, whichever is later. Fellowship will be granted upto the date of submission of Ph.D. Thesis or 5 years of tenure whichever is earlier. No extension is permissible beyond the total period of five years, and the fellow ceases to be a UGC research fellow immediately after expiry of the due date.

6.3 Financial Assistance

The financial assistance available under the scheme is as follows:

Note: At the end of tenure, the books, journals and equipment purchased out of the contingency grant will become the property of the department of the University.

6.4 HRA

- i. Suitable single-seated hostel accommodation may be provided to the candidates in the institutions. In such cases, the fellow is eligible to draw only hostel fees excluding mess, electricity, water charges, etc. A certificate to this effect is to be furnished through the Registrar/Director/Principal. HRA is not permissible for those candidates who are staying in Hostel accommodation.
- ii. In case of non availability of hostel accommodation, the fellow may be provided with single accommodation by the host institution. In such cases, the rent paid by the fellow on actual basis may be reimbursed subject to the ceiling of HRA as per Govt. of India norms.
- iii. If the fellow makes her own arrangements of accommodation, she may be entitled to draw HRA as per categorization of cities by the Govt. of India.

Note: In all the above cases, the fellow will submit a relevant certificate (Annexure-VI) through the concerned University/College/Institute to the identified Agency for settling the claim.

6.5 Medical

No separate/fixed medical assistance is provided. However, the fellow may avail the medical facilities available in the Universities/Colleges/Institutes.

7. LEAVE

- i. Leave for maximum period of 30 days in a year in addition to public holiday may be taken by the candidate. However, they are not entitled to any other vacation, such as summer, winter and pooja vacations.
- ii. Maternity leave as per the Govt. of India norms issued from time to time would be available at full rates of the fellowship once during the tenure of their award.
- iii. Academic leave (without fellowship and other emoluments) shall be permissible only for one year throughout the tenure (for any kind of academic/teaching assignment/foreign visit in connection with research work). The period of leave without fellowship will be counted towards the tenure. Expenditure on foreign visit in connection to research work cannot be claimed from UGC.

Note: All kinds of leave should be approved at the level of the University/College/Institute.

8. PROCEDURE FOR APPLYING FOR THE SCHEME

Applications are invited through online mode once in a year through advertisement in leading newspapers & employment news. Short notification is also uploaded in the UGC website i.e. www.ugc.ac.in.

Note: Candidates have to apply strictly as per the instructions given in the online portal. Incomplete application will not be considered.

9. SELECTION PROCEDURE

- The fellowship will awarded on the basis of recommendation of the Expert Committee constituted by the Commission. The decision of the Commission will be final. Result shall be published on UGC website. Award letters can be downloaded from UGC online application portal.
- ii. If the Fellow is availing any other fellowship/ project from any organization at the time of selection, she shall be required to surrender one award.
- iii. The Commission reserves the right to withdraw/cancel the award without assigning any reason.

10. JOINING OF FELLOWSHIP

The candidate should join the fellowship within 3 months from the date of issue of Award letter, failing which the award will be treated as cancelled.

11. PROCEDURE FOR RELEASE OF GRANT

The fellowship amount shall be disbursed through UGC designated bank into the bank account of the awardee directly. The list of designated branches of UGC identified bank is available on the UGC portal.

The awardee is required to approach the designated branch along with a copy of the Award Letter and Joining Report with photograph, address and contact number in the prescribed proforma as per **Annexure-II.** The awardee is also required to submit the following documents to the designated branch of the UGC designated bank at the stipulated period interval.

- At the end of every three months a 'Continuation Certificate' in the prescribed proforma as per Annexure-III. This will make the fellow eligible to draw the fellowship for the next three months.
- ii. After completion of one year of the award, the concerned fellow shall submit the Progress Report in the proforma prescribed by the UGC as given in **Annexure-IV**.
- iii. The fellow shall also submit accounts of contingency grants in the proforma prescribed by the UGC as given in **Annexure-V.**
- iv. The fellow shall submit the HRA Certificate in the prescribed proforma **Annexure-VI**.

Note: The approved Agency may verify the genuineness of records before disbursal of funds.

12. PROCEDURE FOR MONITORING THE PROGRESS

12.1 Progress report

On the progress of research work, the research fellow shall submit yearly progress report duly signed by Guide and forwarded by HOD and Registrar/Principal/Director of the concerned institution to the identified agency.

12.2 Three Member Assessment Committee Report

After 2 years, progress report of the research work done by the fellow may be examined by Three Member Assessment committee constituted by the university/college/institute and recommendations/comments of the committee (**Annexure-VII**) may be sent to the identified agency.

In case the progress of the work is found unsatisfactory, the award may be terminated by the Commission at any time during the tenure of the award. The decision of the Commission in this regard will be final.

12.3 Fellowship/Assignment/Job

The fellow who is awarded Swami Vivekananda Fellowship for Single Girl Child for research in Social Sciences will not accept any other fellowship or hold any appointment, paid or otherwise, or receive any emoluments, salary, stipend, etc. from any other source during the tenure of the award (except in case of academic leave of one year).

If the fellow wishes to apply for any other fellowship/paid assignment/examination during the tenure of the fellowship, she is not required to obtain NOC from UGC. In case of selection, she would be required to tender resignation from the UGC fellowship.

12.4 Feedback

The fellow shall have to submit feedback in form of the report on the research work done. After completion of the research work the fellow shall submit her research work in the INFLIBNET repository along with the research papers published. At least 2 research papers (1 National and 1 International) must be submitted.

- 1 National/International publication at the time of submitting three member assessment committee report.
- 1 National/International publication by the end of the tenure.

Note: The last 2 installments will be released only after submission of the feedback and research work in the repository.

*The fellow will also submit the Ph.D completion certificate to INFLIBNET.

13. RESIGNATION

The fellow desirous of leaving the research mid-way without completing research degree will have to submit her resignation duly forwarded by the concerned University/College/Institute to the designated agency under intimation to UGC office. The grant will be released upto the date of resignation tendered by the fellow.

14. TRANSFER OF RESEARCH PLACE

Transfer of the Research Place should be done by concerned University/College/Institute under the intimation to UGC and designated agency. Transfer of Research place will be allowed only once during the entire tenure.

15. CANCELLATION OF FELLOWSHIP

UGC may terminate fellowship of any candidate in case of :

- i. If the fellow is found to be ineligible to receive the fellowship, at any point of time during the entire duration of the fellowship.
- ii. Any false information furnished by the applicant.
- iii. Misconduct of fellow.
- iv. Unsatisfactory progress of research work of the fellow.
- v. Any other fellowship/scholarship is drawn from other source(s) during the tenure of the fellowship.

1. OBJECTIVE:

Fellowship is available for pursuing research work leading to award of Ph.D degree under 'SAVITRIBAI JYOTIRAO PHULE FELLOWSHIP FOR SINGLE GIRL CHILD'.

- i. To support higher education of single girl child in Social Sciences.
- ii. To recognize the value of observance of small family norm.
- iii. To recognize the norm of single girl child in society.
- iv. To propagate the concept of single girl child norm.
- v. To promote single girls in the society.
- **2. TARGET GROUP:** A 'single girl child' means the only girl child in the family without having any brother or sister. A girl scholar who is one of the twin daughters/fraternal daughter is also eligible to apply for fellowship under the scheme. If, in a family there is one or more son and one daughter, then the girl child shall not be considered for fellowship under the scheme.

Proof of being single girl child has to be submitted on an affidavit of Rs.100/-Stamp paper from the parents duly attested by SDM / First Class Magistrate / Tahsildar as per the prescribed proforma (Annexure I) at the time of filling the online application. In case, the parents are not alive, affidavit can be submitted by guardian of candidate.

3. NUMBER OF SLOTS: The number of slots for fellowship will be decided every year on the basis of eligible applications complete in all respects, received through online mode.

4. ELIGIBILITY:

- (i) Any single girl child of her parents pursuing Ph.D. in any stream/subject in recognised Universities/Colleges/ Institutes is eligible to apply under the scheme.
- (ii) The scheme is applicable to such a single girl child who has registered herself in regular, full-time Ph. D. program.
- (iii) Admission to Ph.D. Course in part-time/distance mode is not covered under the scheme. A scholar is not eligible for fellowship if the research is intended/pursued through open/ part-time distance education mode or parttime mode.
- (iv) Girl students up to the age of 40 years for general category and 45 years for the reserved categories i.e. SC/ST/OBC and PWD (Persons with Disabilities) as on the last date of submission of online application are eligible.

- (v) The fellowship under this scheme is available for pursuing research work in the following types of institutions only:
 - 1. Central/State Universities included under section 2(f) of UGC Act, 1956 and having valid accreditation from NAAC.
 - 2. Deemed to be Universities under Section 3 of the UGC Act 1956 and having valid accreditation from NAAC.
 - 3. Institutions fully funded by Central or State Governments and empowered to award Degrees.
 - 4. Institutions of National Importance.
- (vi) Non-teaching Employees of any University / College/ Higher Educational Institution*/ Central/ State/ UT Government are not eligible under the scheme for availing the fellowship, even if they are on Study Leave or Extra Ordinary Leave (EOL) to purse Ph.D course. Fellowship is not available for pursuing M.Phil.

5. TERMS AND CONDITIONS:

- (i) Only one benefit: A scholar is eligible to receive only one fellowship at a time. The scholar is required to declare that she is not in receipt of any other scholarship/fellowship from any other source and that she will not accept/receive any other monetary benefit/scholarship/fellowship from any other source. In other words, a scholar who is awarded Fellowship by UGC shall not accept any other fellowship/scholarship or hold any appointment, paid or otherwise, or receive any emoluments, salary, stipend, etc. from any other source during the tenure of the award (except in case of academic leave of one year.
- (ii) If a scholar wishes to apply for any other fellowship/ paid assignment/ examination during the tenure of the fellowship, she is not required to obtain NOC from UGC, however, in case of selection, she would be required to tender her resignation from the UGC fellowship.
- (iii) In case a scholar is already in receipt of any scholarship/fellowship, she is still eligible to apply under the scheme subject to the condition that it is declared in her application. If the scholar is selected under the scheme, she will have to relinquish either the previous scholarship/fellowship/any other monetary benefit or to cancel the selection under these schemes.
- (iv) A scholar who does not complete her research work during the period of fellowship shall not be eligible to apply again under the scheme. Similarly, a scholar who has completely or partially availed any fellowship for Ph.D earlier under any scheme shall also not be eligible for fellowship under the scheme.

- (v) Both the scholar receiving the fellowship and the institution concerned, where the scholar is pursuing her Ph.D are responsible to ensure that the terms and conditions of these schemes are followed properly and only the eligible candidates get the fellowship.
- **6. AADHAAR SEEDING:** The fellowship is directly paid to the research scholars into their bank accounts. For this, the bank account numbers of the scholars are required to be Aadhaar linked and verified. As per the instructions of Government of India, the Aadhaar has been made mandatory for disbursement of all Government subsidies/Scholarships/Fellowships which are disbursed directly into the beneficiary's account. Accordingly, Aadhaar will be used as an Identifier for release of grant under these schemes.
- **TENURE OF FELLOWSHIP:** The tenure of the fellowship is for five years and will be effective from 1st April of the selection year or the actual date of joining under the fellowship in the University/College/Institute, whichever is later. Fellowship will be granted upto the date of submission of Ph.D. Thesis or 5 years of tenure whichever is earlier. No extension is permissible beyond the total period of five years, and the fellow ceases to be a UGC research fellow immediately after expiry of the due date.

Note: At the end of tenure/termination of fellowship/resignation of scholar, the books, journals and equipment purchased out of the contingency grant shall become the property of the institution concerned.

9. HRA: Hostel accommodation may be provided to the scholars by their institutions. In such cases, the scholar is eligible to draw only hostel fees excluding mess, electricity, water charges, etc. In case, a scholar refuses the hostel accommodation, he/she shall not be eligible to draw HRA.

In case of non-availability of hostel accommodation, the scholar may be provided with single accommodation by the host institution. In such cases, the rent paid by the scholar on actual basis shall be reimbursed, subject to the ceiling of HRA as per Govt. of India norms.

If the scholar makes her own arrangements of accommodation, he/she shall be entitled to draw HRA as per ceiling and categorization of cities by the Govt. of India.

In case, the scholar wishes to draw HRA, he/she is required to submit a certificate, in the prescribed format, to her institution.

10. MEDICAL ASSISTANCE: No separate/fixed medical assistance is provided. However, the scholars may avail the medical facilities available in their Institutions concerned.

11. LEAVE:

- (i) **Earned Leave** for a maximum period of 30 days in a year in addition to public holidays may be taken by a scholar. However, they are not entitled to any other vacation, such as summer, winter and pooja vacations, etc.
- (ii) Maternity/paternity leave as per the Govt. of India norms issued from time to time shall be available for female scholars at full rates of the fellowship once during the tenure of the fellowship. The period of leave without fellowship, if any, shall be counted towards the tenure.

Beside this an 'Intermittent Break' for a maximum total period of 1 year may also be permissible to the women scholars. The break can be availed maximum 3 times during the entire period of fellowship. However, the total duration of break shall not exceed one year. No fellowship shall be available for the period of such break(s). This period of intermittent breaks shall not be counted towards the tenure of the fellowship, and thus effectively the total period of fellowship shall remain the same.

- (iii) Academic leave (without fellowship and other emoluments) shall be permissible only for one year throughout the tenure (for any kind of academic/teaching assignment/foreign visit in connection with research work). The period of leave without fellowship will be counted towards the tenure. Expenditure on foreign visit in connection to research work cannot be claimed from UGC.
- (iv) All kinds of leave shall be availed by the scholar only with due approval of the institution concerned.

12. TRANSFER OF FELLOWSHIP: Change of place of research (institution) will be permissible subject to acceptance of the request by both the institutions and issue of NOCs from both the institutions. Transfer of research place be allowed only once during the entire tenure, subject to the condition that research work is not hampered in any way. The period of tenure of fellowship shall, however, be for five years w.e.f. initial joining in the first institution.

The scholar shall not be eligible to receive fellowship from the date of relieving from the first institution till the date of joining in the second institution.

- 13. **RESIGNATION:** A scholar desirous of leaving the research mid-way without completing research degree shall have to submit her resignation to the concerned Institution concerned. On acceptance of the same, the institution concerned is required to immediately mark 'Stop Payment' at the payment portal. The grant shall be released up to the date of resignation tendered by the scholar. In such cases, the scholar shall not be eligible for any other research fellowship leading to award of Ph.D degree.
- **14. CANCELLATION OF FELLOWSHIP:** UGC reserves the right to terminate the fellowship of any awardee in the following cases:
 - i. If the scholar is found to be ineligible to receive the fellowship, at any point of time during the entire duration of the fellowship.
 - ii. If it is found that the fellowship has been availed/is claimed by furnishing false/wrong/misleading information.
 - iii. If any adverse report is received from the institution.
 - iv. Misconduct/misbehavior/corrupt practices.
 - v. Unsatisfactory progress of research work.
 - vi. Violation of terms and conditions of these guidelines.
 - vii. Plagiarism or unethical practices, in any form.

Before terminating/cancelling the fellowship, the scholar shall be given reasonable opportunity to defend himself/herself.

In case the fellowship is terminated/cancelled before submission of thesis, UGC may initiate the proceedings/take action to recover the amount paid to the scholar along with interest.

16. JOINING OF FELLOWSHIP

The candidate should join the fellowship within 3 months from the date of issue of Award letter, failing which the award will be treated as cancelled.

17. PROCEDURE FOR RELEASE OF GRANT

The fellowship amount shall be disbursed through DBT mode. The awardee is required to approach her institution for linking of her ID on the UGC-Canara Bank Scholarship Portal.

18. WHAT THE INSTITUTION HAS TO DO:

- The institution concerned shall check and verify the details of candidate before (a) attempting to link her ID and upload her required details on the scholarship payment portal along with a filled in 'Joining cum Verification Report' and 'Certificate by the Institution' (Annexure-I & II) duly signed/countersigned by the scholar, the Guide, the Head of Department and the Registrar of University/Director of Institute. The **'UGC** Canara Bank Scholarship Payment Portal' can be accessed at https://scholarship.canarabank.in/.
- (b) Apart from verifying the name of the scholar in the selection list from UGC website, the institution is also required to strictly follow the following procedure:
 - (i) Read the guidelines of scheme;
 - (ii) verify and ensure the eligibility of the scholar for the fellowship under particular scheme;
 - (iii) ensure the authenticity and correctness of category/caste of the scholar under which he/she is selected;
 - (iv) verify/authenticate the educational qualifications and marks obtained by him/her;
 - (v) ensure that all the documents required as per the guidelines are completely and correctly filled by the scholar in the formats prescribed by UGC;
 - (vi) Upload the required information, on the scholarship payment portal for generating the payment.
 - (vii) Ensure that all the claims for fellowship and HRA are received and timely uploaded on scholarship payment portal on monthly basis.
 - (viii) Ensure that 'University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D Degree Regulations, 2016' (or as amended) are followed by the Institution including the following:
 - (a) Allocation of Research Supervisor;

- (b) Course Work;
- (c) Research Advisory Committee;
- (d) Evaluation and Assessment Methods, Minimum Standards/Credits for award of Ph.D.
- (ix) A Ph.D. Scholar shall make at least two paper presentations in conferences/seminars before the submission of the dissertation/thesis for adjudication, and produce evidence for the same in the form of presentation certificates and/or reprints.
- (x) The Academic Council (or its equivalent body) of the Institution shall evolve a mechanism using well developed software and gadgets to detect plagiarism and other forms of academic dishonesty.
- (xi) Keep all the hard copies of documents related to candidates in its safe custody during the tenure of fellowship and at least five years after completion of research work/submission of thesis by the scholar.
- (c) The user institutions, which are new to the scholarship payment portal may go through the instructions tutorial available at the link https://ugc.ac.in/ugc_notices.aspx?id=2153
- (d) The data of scholar is required to be uploaded by a 'Maker' and approved by a 'Checker' both of whom should be permanent officials of that university/institution duly authorized by the Head of Institution to access the scholarship payment portal.
- (e) The fellowship and HRA (if any) shall be credited directly into the bank account of the awardee, subject to continuance of research work and submission of monthly confirmation certificates by the scholar to her institution during the first week of following/next month. The format for 'Monthly Confirmation Certificate for claiming Fellowship and HRA' is given in the guidelines (Annexure-III).
- (f) The claim for contingency grant should also be submitted to the institution in the prescribed format as given in the guidelines (Annexure-IV).
- (g) Every claim submitted by a research scholar is required to be checked, verified and uploaded, by the respective institution, on the payment portal on or before 15th of every month. Payments shall be generated only after the approval of uploaded data by the institution concerned on the payment portal. The institutions are solely responsible for genuineness of claim and correctness of data uploaded on the payment portal.

19. Monitoring:

After the end of the second year, the progress of the research work done by the scholar shall be examined by 'Three Member Assessment Committee', constituted by the institution consisting of (i) Supervisor/Guide (ii) Head of Department (iii) One outside expert of subject concerned.

The recommendations/comments of the Committee, in the prescribed format, duly countersigned by the Registrar/Director/Principal shall be uploaded on the portal. A format of the 'Three Member Assessment Committee Report' is given in the guidelines (Annexure-V).

After two years, if the progress of the research work of the scholar is found satisfactory, her tenure will be extended further for a period of three years at enhanced rate of fellowship and contingency as Senior Research Fellow (SRF). In case the work for the first two years is not found satisfactory, an additional year will be given to him/her for improvement and the fellowship will continue as JRF for the third year. In such cases work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years as SRF. Thus, the total period of fellowship is five years, with no further provision of extension.

In case the progress of research work is found un-satisfactory even after 3 years, the fellowship shall be terminated. If the report of the Three Member Assessment Committee' is not given/uploaded on the Portal, the monthly payments shall not be generated beyond the period of three years. The institutions are, therefore, advised to ensure timely assessment of the fellows and constitute the Committee well before the expiry of tenure of two years to avoid hardship to the scholars.

Important Note:

- 1. Strict action shall be taken against the scholar for furnishing any type of wrong/misleading information in respect of her eligibility and other details for getting the fellowship and for furnishing wrong/misleading information during the tenure of research period. UGC reserves the right to take action/initiate proceedings against such scholars and for recovery of full amount of paid fellowship along with interest.
- 2. The institution concerned and its officials shall be held responsible if any payment is made to an ineligible scholar on the basis of uploading of wrong/misleading information on the payment portal. Action shall be taken against the institution/officials including blacklisting of the institution and recovery of paid amount of fellowship with interest from the institution/officials concerned.
- 3. Un-authorized access of the scholarship payment portal shall invite action under the relevant provisions of the Information Technology (IT) Act.
