With reference to the interview held on 27-07-2013 and the resolution of the College  
Committee dt. 17-08-2013, **Tmt. P. Viji, M.Sc.,M.Phil., is appointed Assistant Professor in  
Zoology (Regular vacancy) in this College from the forenoon of 22-08-2013** and placed on  
probation for a period of two years on a monthly salary of ₹ 21600/- (Pay ₹ 15600 + Grade Pay  
₹ 6000/-) plus allowances admissible as per rules, in the Scale of pay of ₹ 15600 - 39100 + AGP  
6000 against the post sanctioned by the Director of Collegiate Education, Chennai in her Procs.  
Rc. No. 21663/G3/2011 dated 14-05-2013. This appointment is subject to the approval of the

The appointee will have to work under the supervision and guidance of the Head of the  
Department concerned and the Principal. Apart from regular academic works, she will have to
