With reference to the interview held on 30-07-2021 and the resolution of the College Committee Meeting dt. 31-07-2021, Dr. B. Pavala Kumar, M.B.A., Ph.D., Assistant Professor in Business Administration (Regular vacancy) in this College from the forenoon of 02-08-2021 and placed on probation for a period of two years on a monthly salary of ₹ 57700/- UGC's Academic Level of Pay Matrix ₹ 57700-182400 (Academic Level 10) and other eligible allowances admissible as per rules against the post sanctioned by the Director of Collegiate Education, Chennai in his Procs. Rc.No. 27502/G3/2019-34 dated 24-02-2021. This appointment is subject to the approval of the Joint Director of Collegiate Education, Madurai Region, Madurai.
