With reference to the interview held on 29-06-2019 and the resolution of the College Committee Meeting dt. 29-06-2019, **Dr. N. Vijayalakshmi, M.F.C.,M.Com.,M.Phil.,Ph.D.,** is appointed as **Assistant Professor in Commerce** (Regular vacancy) in this College from the **forenoon of 01-07-2019** and placed on probation for a period of two years on a monthly salary of ₹ 57700/- UGC's Academic Level of Pay Matrix ₹ 57700-182400 (Academic Level 10) and other eligible allowances admissible as per rules against the post sanctioned by the Director of Collegiate Education, Chennai in her Procs. Rc.No. 34860/G3/2018-7 dated 28-05-2019. This appointment is subject to the approval of the Joint Director of Collegiate Education, Madurai Region, Madurai.

The appointee will have to work under the supervision and guidance of the Head of the Department of Commerce and the Principal. Apart from regular academic works, she will have to engage herself in research work by acquiring funded research projects.
