With reference to the interview held on 16-11-2018 and the resolution of the College  
Committee Meeting dt. 20-11-2018, **Dr. R. Jeeva, M.A.,M.Phil.,Ph.D., is appointed as  
Assistant Professor in Tamil** (Regular vacancy) in this College from the **forenoon of  
05-12-2018** and placed on probation for a period of two years on a monthly salary of ₹ 57700/-  
UGC's Academic Level of Pay Matrix ₹ 57700-182400 (Academic Level 10) and other eligible  
allowances admissible as per rules against the post sanctioned by the Director of Collegiate  
Education, Chennai in her Procs. Rc.No.28289/G3/2017-34 dated 10-10-2018. This appointment  
is subject to the approval of the Joint Director of Collegiate Education, Madurai Region,


