With reference to the interview held on 29-07-2021 and the resolution of the College Committee Meeting dt. 31-07-2021, Dr. V. Manimekalai, M.A.,M.Phil.,Ph.D., Assistant Professor in English (Regular vacancy) in this College from the forenoon of 02-08-2021 and placed on probation for a period of two years on a monthly salary of ₹ 57700/- UGC's Academic Level of Pay Matrix ₹ 57700-182400 (Academic Level 10) and other eligible allowances admissible as per rules against the post sanctioned by the Director of Collegiate Education, Chennai in his Procs.
