With reference to the interview held on 25-07-2013 and the resolution of the College Committee dt. 17-08-2013, **Dr. C. Thangamani, M.A.,M.Phil.,Ph.D., is appointed Assistant Professor in History** (Regular vacancy) in this College from the **forenoon of 22-08-2013** and placed on probation for a period of two years on a monthly salary of ₹ 21600/- (Pay ₹ 15600 + Grade Pay ₹ 6000/-) plus allowances admissible as per rules, in the Scale of pay of ₹ 15600 - 39100 + AGP 6000 against the post sanctioned by the Director of Collegiate Education, Chennai in her Procs.
