
With reference to the interview held on 15-07-2013 and the resolution of the College Committee dt. 17-08-2013, **Dr. C. Ganesan, M.Sc.,M.Phil.,Ph.D., is appointed Assistant Professor in Mathematics (Regular vacancy) in this College from the forenoon of 22-08-2013** and placed on probation for a period of two years on a monthly salary of ₹ 21600/- (Pay ₹ 15600 + Grade Pay ₹ 6000/-) plus allowances admissible as per rules, in the Scale of pay of ₹ 15600 - 39100 + AGP 6000 against the post sanctioned by the Director of Collegiate Education, Chennai in her Procs. Rc. No. 21663/G3/2011 dated 14-05-2013. This appointment is subject to the approval of the Joint Director of Collegiate Education, Madurai Region, Madurai.

The appointee will have to work under the supervision and guidance of the Head of the Department concerned and the Principal. Apart from regular academic works, he will have to engage himself in research work by acquiring funded research projects. He shall produce atleast two research papers / publications in National / International journals in an academic year without fail and perform such other duties as may be assigned to him by the Head of the Department / Principal and the authorities of the College from time to time.

The appointee is further informed that the salary will be paid only after the appointment is approved by the Joint Director of Collegiate Education, Madurai Region, Madurai. If the appointment is not approved by the Joint Director of Collegiate Education, Madurai Region, Madurai, this appointment order becomes null and void and termination gets effective immediately without prior notice.
