We are happy to inform that almost all the teachers who were offered the question setting accepted gladly and completed the assignment within the time frame.

Examinations

The UG Summative practical examinations were conducted from May 28th 2022 to June 10th 2022. The PG Summative practical examinations were conducted from May 30th 2022 to June 10th 2022. The Summative theory examinations conducted from June 23rd 2022 to July 9th 2022 (16 days). A total number of 3583 students of U.G, P.G, Certificate Course, PG Diploma Courses appeared for the examinations. During the course of examinations, a total number of 58 students (130 scripts) were absent in the 65 sessions of examinations. We regret to inform that 5 students indulged in malpractices during the examinations. The list of students indulged in malpractices are enclosed.

A total number of 25,599 answer scripts (18,958 current exams, 114 arrear exams and 5,499 practical exams, 978 Part V exams, and 50 OMR scripts) were evaluated. Answer scripts of five students who indulged in malpractice, were not valued and their results withheld. In total 24,398 scripts out of 25,599 scripts passed the examinations. The overall pass percentage is 95.31%. 27 private students appeared for the examinations and 20 students passed out.

Evaluation



We sincerely thank the services of 5 staff members of our college for acting as flying squad to make surprise visit and to check the students in the examination halls. 38 students (40 scripts) applied for revaluation 4 scripts were declared as pass in the revaluation [10.00%]. Supplementary Examinations were conducted for the UG, PG out-going students who got 1 or 2 arrears in the final semester only. 123 Students (139 scripts) appeared for the supplementary exams. 90 Students (104 scripts) cleared the papers [74.82%].

In our College several Departments conducted value added certificate courses for the career benefit of the students. Supplementary Examinations were conducted for the UG, PG out-going students who got 1 or 2 arrears in the final semester only. 109 Students (127 scripts) appeared for the supplementary exams. 97 Students (116 scripts) cleared the papers [91.34%].

In our College several Departments conducted value added certificate courses for the career benefit of the students. In this regard, in the year 2022– 2023 five departments have organized 8 different courses and 331 students were given certificates.

Awards Committee Meeting was conducted on 20.05.2023 and the results were published in our College official website and also our college apps VHNSNC on 20.05.2023 (last date of examinations 15.05.2023). The revaluation and supplementary results were published on 07.06.2023. In overall, 90.89% of UG scripts, 93.92 % of PG scripts, 67.80 % of Certificate Course scripts, 100 % of Diploma course scripts were declared as pass. In our College, out of 945 final year UG students 838 will get their degrees [88.68%] and out of 306 final year PG students 294 will get their degrees [96.08%] and out of 33 final year PGDCA students 33 will get their degrees [100%].

Report on the Summative Examinations, November 2023

A report on the Summative Examinations under the Autonomy Stream, held in the month of November 2023, submitted to the Principal.

Pre – Exam Preparations

A total number of 390 current examination question papers & 273 arrear examination question papers were set by 133 examiners. All the questions papers were set by teachers with not less than 6 years of teaching experience. We are happy to inform that almost all the teachers who were offered the question setting accepted gladly and completed the assignment within the time frame.

Examinations

The UG Summative practical examinations were conducted from October 10th 2023 to October 20th 2023. The PG Summative practical examinations were conducted from October 12th 2023 to October 21st 2023. The Summative theory examinations were conducted from November 16th 2023 to December 2nd 2023 (22 days). A total number of 3617 students of U.G, P.G, Certificate Course, PG Diploma Courses appeared for the examinations. During the course of examinations, a total number of 98 students (379 scripts) were absent in the 77 sessions of examinations. We regret to inform that 5 students indulged in malpractices during the examinations. The lists of students indulged in malpractices are enclosed.

A total number of 25975 answer scripts (20,554 current exams, 1,379 arrear exams and 2,757 practical exams, 1,285 OMR scripts) were evaluated. Answer scripts of five students who indulged in malpractice, were not valued and their results withheld. In total 22,631 scripts out of 25,975 scripts passed the examinations. The overall pass percentage is 87.13%. 85 private students appeared for the examinations and 45 students passed out.

We are proud to place on record that we have conducted all the semester examination's theory papers using OMR (Optical Mark Recognition) statements. We have also used OMR foil cards for our practical examinations (both internal & external). The usage of OMR machine in our Controller of Examinations office was very helpful in bringing out the results in a more effective manner and in a short duration.




We place on record our sincere thanks and gratitude to a team of dedicated College staff members for rendering their assistance in the successful conduct of the examinations.

Evaluation


A total number of 161 external examiners (133 for theory & 28 for practical) were appointed to carry out the evaluation work. The examiners were from *Tiruchirappalli*, Madurai, Thirumangalam, Thiruvudagam, Tirunelveli, Melur, Sivakasi, Sattur, Kovilpatti, Aruppukottai and Virudhunagar. The Central Valuation was started on November 15th, 2023 and was concluded on 2nd December, 2023 (16 days). The OMR mark entries in the answer scripts were verified by our teachers, which helped for effective valuation. We sincerely thank the services of 12 faculties of our College for acting as flying squad to make surprise visit and to check the students in the examination halls. 47 students (64 scripts) applied for revaluation out of which five scripts were declared as pass in the revaluation [7.81%].

In our College several Departments have conducted value added certificate courses for the career benefit of the students. In this regard, in the year 2023 - 2024 four Departments have organized 4 different courses and 314 students were given certificates.

23rd Awards Committee Meeting was conducted on 11.12.2023 and the results were published in our College official website and also our college apps VHNSNC on 12.12.2023 (last date of examinations was 02.12.2023). The revaluation results were published on 26.12.2023. In overall, 85.78% of UG scripts, 93.06% of PG scripts, 100 % of Certificate Course scripts, 99.49 % of Diploma course scripts were declared as pass.
