MEMORANDUM

The undersigned hereby offers to Mr. Gopinath M Son of Sh. Maya Krishnan R a post of Constable (General Duty) in the minimum pay of Rs. 21700-69100/- in the Pay Matrix (Level-3) in Sashastra Seema Bal. He will also be entitled to draw other allowances, at the rates as admissible to Central Govt. employees, subject to the conditions as laid down in the rules and orders governing the grant of such allowances in the Force from time to time.

2. The terms and conditions of appointment are as follows:-

- i. On joining the Force, he/she will be governed by the Sashastra Seema Bal Act 2007 & Rules 2009, manuals & other rules/orders as issued & amended from time to time by the Government.
- ii. The appointment is purely temporary but likely to continue. He/she will be on probation for a period of 02 (Two) years from the date of appointment. The competent authority as prescribed under SSB Rules may, for the reasons to be recorded in writing, extend the period of probation for such further period or periods not exceeding two years or may during the period of probation, terminate his services with assigning reasons. His/her permanent appointment to the post, however, will depend upon various factors governing terms of permanent appointment to such post in force at that time.
- iii. - iii. You will be on probation for a period of two years.
- iv. The Appointing Authority may discharge you from service at any time during the period of probation, if in their opinion, your work or conduct during this period is considered **unsatisfactory**, or shows that you are not fit for permanent appointment.
- v. You will be considered for confirmation in service on your successful completion of probation and if you are found fit in every respect for confirmation.
- vi. It should be understood that your appointment is subject to any change in the Recruitment Rules framed from time to time and that you will have no claim for compensation in consequence of any such change.
